HIGHLY-TRAINED CRISIS COUNSELORS WHO CAN HELP WITH A WIDE VARIETY OF PRESENTING CONCERNS, INCLUDING SUICIDAL IDEATION, RELATIONSHIPS, HOUSING, HOMICIDAL IDEATION AND MANY OTHER POTENTIAL AREAS OF DISTRESS. IN 2024, LICC'S 988 CRISIS COUNSELORS RECEIVED 11,459 CALLS FROM INDIVIDUALS WITH AN ANSWER RATE OF 91% (CALLS THAT WERE NOT ANSWERED WERE ROUTED TO A BACK-UP CENTER). THESE NUMBERS REFLECT A 30% CALL INCREASE AND 2% ANSWER RATE INCREASE FROM 2023.

THE INCREASE IN CALL VOLUME IN 2024 LED TO CHANGES IN PROGRAMMATIC AND ADMINISTRATIVE NEEDS RESULTING IN THE ADDITION OF A PROJECT ADMINISTRATOR, AS WELL AS ADDITIONAL SHIFT SUPERVISORS TO PROVIDE 24-HOUR SUPERVISORY SUPPORT AND ACCESS.

EXAMPLES OF 988 CALLS: (CALL DETAILS HAVE BEEN REDACTED OR ALTERED TO PRESERVE CLIENT CONFIDENTIALITY.)

A HIGH SCHOOL SENIOR CALLED 988, FEELING OVERWHELMED AND DEPRESSED DUE TO ACADEMIC STRESS AND BULLYING. THE CALLER DISCLOSED THAT SHE WAS NOT THINKING ABOUT SUICIDE BUT WAS CALLING TO AVOID SELF-HARM. THE COUNSELOR VALIDATED THE CALLER AND ALLOWED HER SPACE TO SHARE HER FEELINGS. TOGETHER, THEY EXPLORED COPING SKILLS, MOTIVATING FACTORS TO AVOID SELF-INJURY AND MORE ADAPTIVE WAYS TO ADDRESS CHALLENGING EMOTIONS. WHERE HE WAS CONSIDERING ENDING HIS LIFE. THE COUNSELOR WAS ABLE TO BUILD A RAPPORT WITH THE CALLER AND HE AGREED TO MOVE AWAY FROM THE TRAIN PLATFORM WHILE THE CONVERSATION CONTINUED. THE CALLER DISCLOSED A HISTORY OF EMOTIONAL DIFFICULTIES AND ABUSE, AS WELL AS CHALLENGES FACED AS A RESULT OF HIS QUESTIONING HIS SEXUALITY. THE COUNSELOR VALIDATED THE DIFFICULTY OF FEELING ISOLATED AND MISUNDERSTOOD BY LOVED ONES AND OFFERED SEVERAL REFERRALS. THE COUNSELOR WAS ABLE TO HELP THE CALLER IDENTIFY CONNECTIONS TO LIFE AND ADDITIONAL COPING SKILLS HE COULD POTENTIALLY UTILIZE TO AVOID ATTEMPTING SUICIDE. THE CALLER EAGERLY ACCEPTED REFERRALS AND AGREED TO IMMEDIATELY DRIVE TO A WALK-IN MENTAL HEALTH FACILITY FOR EVALUATION. HE ALSO AGREED TO A FOLLOW-UP CALL FROM A 988 COUNSELOR. WHEN THIS CALL WAS MADE A COUPLE OF DAYS AFTER THE INITIAL CALL, THE CALLER SHARED THAT HE WAS ON HIS WAY TO A THERAPY APPOINTMENT AND THAT HE WAS DOING "MUCH BETTER" SINCE HIS INITIAL CALL.
